
Limited Warranty Statement(s)





The Infinivent cannot be altered in any way by the end user. The warranty is extended to the original purchaser, whose name appears on the warranty certificate and is in effect at the location shown on the warranty certificate. The warranty applies to residential installations or commercial installations and is non-transferable.

The word "defect(s)" as used in this warranty is defined as imperfections that impair the functionality of the Infinivent.

One (1) Year Limited Product Warranty

For one (1) year(s) from the date of purchase (Registration of product required), when the solar attic/roof vent is operated and maintained according to instructions attached to and/or furnished with the product, the Infinivent brand of C4P Inc. will pay for factory specified parts and repair labour to correct defect(s) in materials or workmanship as outlined below. Service must be provided by a Infinivent designated service company. This limited product warranty is valid only in the Contiguous United States, District of Columbia, Alaska, Hawaii, and Canada and applies only when the solar attic/roof vent is used in the country in which it was purchased. This limited product warranty does not apply outside the 50 United States and Canada. Proof of original purchase date is required to obtain service under this limited product warranty.

- Warranty registration must be completed within 30 days of receipt of the product in order to extend, at no charge, the standard 90-day limited product warranty to one (1) year(s) from date of purchase.
- C4P Inc., reserves the right to determine the validity of all warranty claims.
- Warranty is void if the product has been misused or damaged or if evidence is present that the product was altered, modified, or serviced by unauthorized service technicians.

Twenty Five (25) Year(s) Limited Performance

For twenty five (25) year(s) from the date of purchase (Registration of product required), when the solar attic/roof vent is operated and maintained according to instructions attached to or furnished with the product, the Infinivent brand of C4P Inc. will pay for factory specified parts and repair labour to correct defect(s) in materials or workmanship as outlined below in respect to the performance of the Polycrystalline Modules specifically. Service must be provided by a Infinivent designated service company. This limited performance warranty is valid only in the Contiguous United States, District of Columbia, Alaska, Hawaii, and Canada and applies only when the solar attic/roof vent is used in the country in which it was purchased. This limited performance warranty does not apply outside the Contiguous United States, District of Columbia, Alaska, Hawaii, and Canada. Proof of original purchase date is required to obtain service under this limited performance warranty.

- Warranty registration must be completed within 30 days of receipt of the product in order to extend, at no charge, the standard 90-day limited performance warranty to twenty five (25) year(s) from date of purchase.
- C4P Inc., reserves the right to determine the validity of all warranty claims.
- C4P Inc. warrants that for a period of twenty five (25) year(s) the module will maintain a performance as set forth below:
 - During the first year, C4P Inc. warrants the actual power output of the module will be no less than 96% of labeled power output
 - From year 2 to 25, the actually power decline will be no more than 0.75% per annum; by the end of year 25, the actual power output will be no less than 78% of the labelled power output.
- C4P Inc. warrants that for a period of five (5) year(s) to cover the performance and operation of the brushless fan motor for the intended use and maintenance of the solar attic/roof vent.

This limited warranty does not cover:

- 1. Service calls to correct the installation of your solar attic/roof vent, or to instruct you on how to use your solar attic/roof vent.
- Repairs on your solar attic/roof vent when it is used for purposes other than normal recommended use or when it is used in a manner that is contrary to published user or operator instructions and/or installation instructions.
- 3. Damage resulting from accident, alteration, negligence, misuse, abuse, fire, flood, acts of God, improper installation, installation not in accordance with electrical or plumbing codes, or use of consumables or cleaning products not approved by C4P Inc.
- 4. Cosmetic damage, including scratches, dents, chips or other damage to the finish of your solar attic/roof vent, unless such damage results from defect(s) in materials or workmanship and is reported to C4P Inc. within 10 days from the date of purchase.
- 5. Costs associated with the removal from your home of your solar attic/roof vent for repairs.
- 6. Repairs to parts or systems resulting from unauthorized modifications made to the solar attic/roof vent.
- 7. Expenses for travel and transportation for product service if your major appliance is located in a remote area where service by an authorized C4P Inc. servicer is not available.
- 8. The removal and reinstallation of your solar attic/roof vent if it is installed in an inaccessible location or is not installed in accordance with published installation instructions.
- 9. C4P Inc. is not liable for the direct or indirect loss, consequential damage, or any other claim except provided for in this warranty.
- 10. C4P Inc. is not liable for the direct or indirect injuries as a result of mishandling the product or failure(s) to follow proper safety guideline and/or instructions.

The cost of repair or replacement under these excluded circumstances shall be borne by the customer.

CUSTOMER'S SOLE AND EXCLUSIVE REMEDY UNDER THIS LIMITED WARRANTY SHALL BE PRODUCT REPAIR AS PROVIDED HEREIN. IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO ONE YEAR OR THE SHORTEST PERIOD ALLOWED BY LAW. C4P INC. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE OR PROVINCE TO PROVINCE.
